TUITION INSTALLMENT PAYMENT PLAN AGREEMENT

A tuition installment payment plan is available to students enrolling for 3 credits or more in the fall and spring semesters. It allows students to defer the payment of tuition beyond the normal due date, for a non-refundable fee of \$25.00. This fee is included with the Down Payment due upon registration. All payments must be completed by mid-semester. Students wishing to use the tuition installment payment plan must complete this agreement. Students failing to make timely payments will be denied transcript services and will not be allowed to register for any future semesters. A late payment fee of \$15.00 will be charged for all payments received after the published due dates. Unpaid amounts will be referred to collection. *Note: Completion of this agreement fully obligates students to fulfill the payment agreement. The \$25 plan fee will be charged to each student, each semester.*

Please complete both sections of this agreement and bring with payment to the Cashiers Office, Kinney Hall, Room K-508 upon registration. All installment payments must be made to the Cashiers Office.
